#### **Cancellation and refunds**

All cancellations must be made in writing by email to biaevents@bioindustry.org.

If you cancel within five working days of the event, the full fee remains payable. Cancellations made more than five working days before the event will be subject to a 20% administration fee.

- Companies may nominate a substitute from within their own organisation if a registered person is unable to attend. Substitution is not guaranteed and is liable to consideration by the event organisers.
- Should we be required to cancel an event due to circumstances outside of our control, we will
  not refund any fees paid to us.
