

Terms and Conditions – Gala Dinner 2020



Please note: All table hosts are asked to make a donation of **£250.00** to the BIA chosen charity for the 2020 Gala Dinner. This amount will be invoiced separately on receipt of your booking.

Payment of fees - By reserving your table or tickets for the 2020 Gala Dinner you are committing to attend and therefore pay the applicable amount (complying with the cancellation policy below).

- **All payments should be made by 31 December unless otherwise agreed with the BIA.**
- Reservations taken in **January 2020** must be paid for by credit card at the time of booking.
- You are encouraged to pay by means of **credit/debit card**. For those booking from abroad these are the only methods of payment acceptable. UK delegates may also pay by BACS or cheque on receipt of an invoice emailed out automatically upon registration.
- **Cancellation** - All cancellations must be given in writing via email to biaevents@bioindustry.org. If you cancel within **30 WORKING DAYS** of the event 50% of the fee remains payable. For cancellations made within **20 WORKING DAYS** of the event, the full amount remains payable. We shall not be liable to you for travel, accommodation or other costs and expenses incurred (included wasted costs and expenses) if we are required to cancel or relocate the conference as a result of an event outside our control (including, without limitation, to acts of God, floods, lightning, storm, fire, explosion, war, military operations, acts of terrorism or threats of any such acts, any strike action, lock-outs or other industrial action and a pandemic, epidemic or other widespread illness).
- **Data protection** - Personal data is gathered in compliance with the Data Protection Act 1998. Your information will be maintained on the UK BioIndustry Association database and used to register you for this event and/or contact you by email, phone or post with information about other events, products and services which we or our associated companies/associations provide. We may also from time to time act on behalf of selective third parties to communicate information we believe is of relevance to your organisation or role within your company.
